Representatives of Ladysmith Family and Friends showed a short video about the history of LaFF and thanked the Town for its past and ongoing support of the organization. They discussed the organization's increasing enrolment and ongoing successes in supporting families and providing a solid foundation for the children of the community.

Council members expressed their appreciation for LaFF and the contributions its staff and volunteers have made to the community over the years.

Proposed Logging Plan

Representatives of BC Timber Sales and consulting firm Madrone showed slides of a proposed timber harvesting plan in the hills surrounding Ladysmith known as Block B091C3Z6. responded to concerns expressed by Council and the Town with respect to the effect on the Holland Creek watershed of logging and road building.

BYLAW NO. 1852

A bylaw to amend "Town of Ladysmith Dog Licencing, Control and Pound Bylaw 1995, No. 1155"

WHEREAS Sec. 8(3)(k) of the *Community Charter* authorizes a municipal council to establish a bylaw to regulate, prohibit and impose requirements in relation to animals;

AND WHEREAS a Council may, from time to time, amend such a bylaw as deemed appropriate;

NOW THEREFORE the Council of the Town of Ladysmith in open meeting assembled enacts as follows:

- Delete Section 13 of Bylaw No. 1155 in its entirety. The remaining sections SHALL NOT be renumbered.
- (2) Add the following bolded and underlined text to the first sentence of Section 14(a):

"No owner of any dog shall permit or allow such dog to be at large on any **private property (other than that of the dog owner), public** highway, street, lane, park or any other public place, unless it is accompanied by a competent person and is restrained by that person by means of an adequate leash attached to the dog."

(3) This bylaw shall be cited for all purposes as "Town of Ladysmith Dog Licencing, Control and Pound Bylaw 1995, No. 1155, Amendment Bylaw 2014 No. 1852".

BYLAW NO. 1862

A Bylaw to provide for the indemnification of municipal officials

WHEREAS the Local Government Act, section 287.2 authorizes the Town of Ladysmith to enact a bylaw to provide indemnity to municipal officers, employees and elected officials acting reasonably and in good faith in performing the duties and functions of their positions with the Town of Ladysmith;

NOW THEREFORE the Council of the Town of Ladysmith in open meeting assembled ENACTS AS FOLLOWS:

Citation

 This Bylaw may be cited as the "Town of Ladysmith Indemnification Bylaw 2014, No. 1862".

Interpretation

2. In this bylaw

"indemnify" means to pay the amounts required or incurred

- (a) to defend an action or prosecution brought against a person in connection with the exercise or intended exercise of the person's powers or the performance or intended performance of the person's duties or functions;
- (b) to satisfy a judgment, award or penalty imposed in an action or prosecution referred to in paragraph (a); or
- (c) in relation to an inquiry under the Public Inquiry Act, or to another proceeding, that involves the administration of the Town of Ladysmith or the conduct of Town of Ladysmith business,

but does not extend to a fine that is imposed as a result of a conviction for an offence, other than a strict or absolute liability offence;

"municipal official" means

- (a) a current or former member of Council of the Town of Ladysmith;
- (b) a current or former employee or officer of the Town of Ladysmith; or
- (c) a person who is or was a person referred to in section 287 (1) of the Local Government Act.

but only in relation to the exercise of powers or performance of duties or functions for or on behalf of the Town of Ladysmith, but does not include an independent service provider, professional advisor or contractor engaged by the Town of Ladysmith from time to time on a fee for service basis; and

"willful misconduct" in relation to a municipal official, includes, without limitation, willfully acting contrary to the terms and conditions of his or her employment or to a lawful direction or order of a superior.

Indemnification

- 3. The Town of Ladysmith will indemnify every municipal official against an action or prosecution brought against the municipal official, including, for certainty, reasonable legal costs incurred in relation to the proceeding, if the person to be indemnified:
 - (a) promptly, after being served with a document initiating an action or prosecution, delivers a copy of same to the Town of Ladysmith's corporate officer;

(b) does not admit or assume liability, enter into a settlement, or enter a guilty plea except with the approval of Council;

- (c) consents in writing to the Town of Ladysmith having sole discretion to appoint and instruct legal counsel, conduct all necessary investigations, to negotiate and settle the action or prosecution, provided that if the person believes they have an interest that is in conflict with the interest of the Town of Ladysmith the person is entitled to independent legal counsel; and
- (d) assists in providing and securing information, evidence, and witnesses, and cooperates with the Town of Ladysmith and their legal counsel in the defence of the action or prosecution.

Exceptions

4. The Council will not seek indemnity against a municipal official in respect of any action of the municipal official which results in a claim for damages against the Town of Ladysmith, except where a court of competent jurisdiction makes a finding that the person has been guilty of dishonesty, gross negligence, or malicious or willful misconduct.

Repeal

"Ladysmith Officers and Employees Indemnification Bylaw 1981 No 721" is hereby repealed.

Dear Mayor Hutchins and Council:

The Board of Education of School District 68 (Nanalmo-Ladysmith) is considering whether it should make a request to the Minister of Education that the size of the Board be reduced.

- Currently the Board of Education has nine trustees elected at large from the entire school district once every four years, effective November 2014.
- It is being proposed that the Board of Education consist of seven trustees elected at large from the entire school district once every four years (effective November 2014)
- The majority of school districts in British Columbia that are the size of Nanaimo-Ladysmith operate with Boards of Education of seven trustees.
- The total cost savings from reducing the number of trustees by two is estimated to be about \$45,146.

Attached is an information sheet that provides an overview of the Board's rationale for considering such a move, along with comparison with six other school districts that are a similar size to our district.

The Board invites public input on this proposal. There are several ways you can provide your comments to the Board:

Background Information –

Proposal to Reduce School District 68 (Nanaimo-Ladymith) Board of Education from 9 to 7 Trustees

Rationale:

During the first months after taking office in December 2011, the Trustees of the Board of Education (School District 68 Nanaimo-Ladysmith) made the decision to put into place Board governance policies and administrative procedures that moved the Board into a governance model.

The majority of the working committees were eliminated. Workshops and in-service sessions were held to train the Trustees in the governance model. Policies and procedures have been eliminated and/or rewritten to facilitate the governance model.

This model is significantly different from the management model of involvement that had been previously in effect. The governance model requires Trustees to operate at the policy level and leaves the day-to-day management of the district to the managers.

Given that the Board of Education of School District 68 (Nanaimo-Ladysmith) is now a governance Board and given that the Board must continue to find monies to realize a balanced budget, it is an opportune time to consider reducing the number of Trustees serving the District. The consultation process will offer an opportunity to consider the cost/benefit analysis of Trustees in the Governance model and allow for public input.


We would welcome your support in this request to partner on this important project for the Festival of Lights Society.
