a. Development Permit application #3060-16-03

Lots 7 & 8, District Lot 147, Oyster District, Plan 85271 (1201 & 1251 Christie Road)

Project Engineer, J Salter introduced the designs for the proposed Multi-Unit Residential development at 1201 & 1251 Christie Road, and presented a revised site layout and landscape plan.
