The meeting was called to order at 5:15 p.m.

1. NOMINATION/ELECTION OF CHAIR

Members agreed to postpone the election of Chair until the next meeting.

2. **AGENDA**

It was moved, seconded and carried that the Agenda of September 28, 2017 be approved with the addition of 7(f) Painting without a Façade Development Permit.

3. **MINUTES**

It was moved, seconded and carried that the Minutes of July 19, 2017 be adopted.

4. **COUNCIL REFERRALS**

At their meeting on August 21, 2017 Council passed the following motion:

"It was moved and seconded that Council direct staff to refer the role of the Finnish Community in Ladysmith heritage to the Heritage Revitalization Advisory Commission to investigate ways to promote and celebrate that community."

Councillor Hutchins provided information on the Council referral to HRAC. Members discussed opportunities to research and recognize the involvement of ethnic communities in the development of Ladysmith.

It was moved, seconded and carried that the Heritage Revitalization Advisory Commission will investigate the recognition of ethnic communities in Ladysmith during the Heritage Strategic Plan Implementation Plan review.

Councillor Hutchins also provided an update on the Bio-Solids composting facility development, and progress of the Waterfront Area Plan.

6. HERITAGE PROJECT(S)

a) HRAC Budget Overview 2018

Members reviewed the Heritage Project Timeline for 2018, including Heritage Week, the Heritage Strategic Plan Implementation Plan review, and the Heritage Inventory. Members requested that staff provide a budget summary for HRAC at the next meeting.

c) Canada 150 Project

R. Johnson provided an update that M. Sacht has begun conducting heritage interviews with citizens. M. Sacht will ask HRAC members to provide recommendations for additional individuals to interview.

d) Heritage Tree Preservation

Councillor Hutchins noted that heritage tree preservation was not included in Council's current strategic plan. Members discussed a bylaw for the protection of heritage trees.

It was moved, seconded and carried that the Heritage Revitalization Advisory Commission recommend to Council that a copy of the draft tree bylaw (2008) be referred to the Heritage Revitalization Advisory Commission for review.

e) Knight's Clock

Members discussed Knight's Clock and suggested that upgrades be done to the clock.

f) Painting without a Façade Development Permit

Members discussed recent façade renovations in the heritage downtown that were completed without review by HRAC.

It was moved, seconded and carried that the Heritage Revitalization Advisory Commission is concerned by unauthorized façade improvements (e.g. paint colour) and requests that Council consider enforcement of bylaws for façade improvements.
