Re: AWARD OF TENDERS FOR CONCRETE FORMING AND REINFORCING BAR
INSTALLATION FOR LADYSMITH COMMUNITY RESOURCES CENTRE AND CIVIC
SQUARE

RECOMMENDATION(S):

It is recommended that Council award the concrete forming contract for the Ladysmith Community Resources Centre and Spirit Square to Dalcon Construction in the amount of \$147,747 plus applicable taxes; and that Council award the concrete reinforcing bar installation contract for the Ladysmith Community Resources Centre and Spirit Square to Allstar Rebar Ltd. in the amount of \$24,535 plus applicable taxes.

PURPOSE:

The purpose of this staff report is to seek Council's approval to award contracts for concrete forming and reinforcing bar installation for Ladysmith Community Services Centre and Civic Square.

INTRODUCTION/BACKGROUND:

Both tenders were advertised on the Town's website. In addition, the Construction Manager, Windley Contracting Ltd., invited four contractors to bid on the forming contract as they had confirmed budget pricing in the past. Competitive bids were received from two companies for the concrete forming, and from four companies for the reinforcing bar installation.

SCOPE OF WORK:

Both companies have completed similar work in the past and have a good reputation. The bids conform to the work required and the Construction Manager is satisfied with both bids.

ALTERNATIVES:

Council can choose not to award one or both of these contracts.

FINANCIAL IMPLICATIONS:

The work falls within the overall approved budget of the Ladysmith Community Services Centre/Civic Square project.
