I am a home owner of 208 Dogwood Dr, Ladysmith, BC. We bought our home in 2015. When we bought here we were unaware that our home was in an area considered commercial. We have noticed a dramatic increase in traffic along Dogwood, and in particular, trucks, most exceeding the speed limit. It seems that once vehicles are on Dogwood, they speed up. Our house is across from a crosswalk and countless times I see vehicles speeding by pedestrians waiting to cross. With that said, with the addition of The Bayview Brew Pub, Dalby's Highrise, and the Jailhouse Condos being built, the traffic will triple if not quadruple. With this increase, alight needs to be installed.

In particular reference to 202-204 Dogwood, the application was accepted for a Brewpub, and then switched to include a lounge. The location has only 12 parking spots. There is no parking along Dogwood.

I believe that the Town of Ladysmith is making a big mistake by allowing this project to go forward.

HI, I am glad to see the town decided to ask for public comment on the above application. I have reviewed the application and found that there was a lot of information that was not included or misleading. I contacted staff, Jake, with some questions to see if there was more info available. He was able to help with some answers and then directed me to contact the Liquor Control Branch about other information. I did this, but they do not talk to the public regarding applications.

I contacted Jake again and he informed me that all the information they have is what is in the binder and on line. That information was supplied to them from the LCB.

The main item missing from the application is the letter of intent. It is to include many items that could be of concern to me and my neighbours. Other parts of the application are left blank. The operating hours are somewhat confusing. I can make assumptions about the hours, but they should really be clear to understand.

Because of this I would ask that the town request that a new application that is properly filled out and complete with the required information is made available for review so that informed comments may be submitted for consideration. Is that not the point of this process.

I would also like to mention that throughout the whole process of this project, the lack of proper information has been an issue. Drawings were not made available that were not relevant and accurate at the time of the public hearing and 3rd reading before council. Inaccurate drawings were also submitted at the development permit stage. I have been involved with various members of staff throughout this process and have found them to be very professional in their dealings with me. But with the processes the town has in place, there were areas where things such as inaccurate drawings were allowed to be included. This makes it difficult to see what the final product will be and to provide relevant comments.

In closing I would request that the application be sent back to the LCB and that the process start again when a completed application is submitted.
