# 6.1 RCMP 2<sup>nd</sup> Quarter Report

S/Sgt. Trevor Busch, Detachment Commander of the Ladysmith RCMP, presented the 2<sup>nd</sup> Quarter Report for July to September 2025.

The detachment saw an overall increase in calls for service, with notable rises in traffic-related incidents and wellbeing checks. Property and drug/alcohol-related offences declined. The detachment has already surpassed several of its annual proactive policing goals, and S/Sgt. Busch emphasized their continued commitment to proactive enforcement, community engagement, and wellness initiatives.

S/Sgt. Busch responded to Council's questions, and Council thanked him for his thorough reports.

They then sought clarification regarding why the plan was not referred to CPAC, and asked if the Town would consider contacting the developer to recommend a follow-up public presentation outlining what has been approved through the permitting process.
