### **1. CALL TO ORDER**

## 7. PRESENTATION

### 7.1 Mike Smith, Ladysmith Golf Club Society

Mike Smith provided an overview of the history and development of the course and its landscaping, including a summary of financial information. He outlined staffing and volunteer involvement, the organization's mandate to encourage participation in the sport, including junior programming, and described existing sponsorships and scholarships.

Mr. Smith noted that usage increased significantly following COVID-19. He also spoke to the cooperative and valued relationship with the Town for watering and maintenance of the greens through shared equipment, noted that the greens enhance tourism in the community, and extended an invitation to Council members to visit the course. Council thanked Mr. Smith for his presentation and work in the community.

### 9.1 2026 Budget Deliberations – General Capital and General Operations Update

#### CS 2025-340

1. Confirm the general budget municipal tax levy at \$9,220,183 or 5.82% budget increase; and
2. Provide early budget approval for the following projects:
  - Uplands Remediation – Final Phase for \$200,000;
  - Public Engagement – City Hall Options for \$40,000;
  - Brown Drive Park Playground Replacement for \$210,500;
  - Forrest Field Artificial Turf Replacement for \$1,190,000;
  - Watermain Replacement - Buller 4<sup>th</sup>-6<sup>th</sup> for \$400,000;
  - Articulating Loader – Compost for \$200,000; and
  - Storm Main - French Street to Kitchener Street for \$27,005.

## **9.3 Lot 108 Park Implementation - Phase 2 Tender Results**

## **9.4 Remedial Action Requirement - 670 Farrell Road**

By unanimous consent, Council decided to consider subsection 7 of the recommendation for Item 9.4 “Remedial Action Requirement - 670 Farrell Road” separately.

### **CS 2025-344**

That Council:

1. Declare the runoff from the property with the legal description Lot 12 District Lot 41 Oyster District Plan EPP119981 (670 Farrell Road) (the “Subject Property”) and described in the December 16, 2025 staff report to Council, a nuisance pursuant to section 74(1)(c) of the *Community Charter*;
2. Declare the piles of soil at the Subject Property and described in the December 16, 2025 staff report to Council (the “Piles of Soil”),

to be structures that are in an unsafe condition pursuant to section 73(1)(a) of the *Community Charter*, and a nuisance pursuant to section 74(1)(a) of the *Community Charter*;

3. Pursuant to section 72 of the *Community Charter*, require the owner to complete the following remedial actions, with required permits, no later than January 27, 2026:
  - a. Installing a “leave strip” at the bottom of the Subject Property immediately adjoining Farrell Road, under the supervision of a professional engineer, or a suitable alternative acceptable to the Town Engineer, to capture runoff from the site and decant it into the Town’s stormwater system;
  - b. Replacing silt fencing, soil coverings and silt traps currently in place with semi-permanent erosion and sediment control measures, on the Subject Property, under the supervision of a professional engineer, or a suitable alternative acceptable to the Town Engineer to capture runoff from the site and decant it into the Town’s stormwater system; and
  - c. Removing the large piles of soil from the Subject Property;
4. Direct staff to issue notice of the remedial action requirements to the owner and charge holders pursuant to section 77 of the *Community Charter*;
5. Direct staff to undertake the remedial action outlined under recommendation 3, without further notice, and at the owner’s expense, if the remedial action is not completed by the owner by January 27, 2026; and
6. Direct staff to recover any municipal costs incurred in fulfilling the remedial action outlined under recommendation 3, pursuant to section 17(1) and 17(2) of the *Community Charter*.

Confirming bylaw requirements and the status of permits; and
