7.1 Request for Additional RCMP Members

That Council:

1. Authorize and include in the 2026-2030 Financial Plan an increase of one (1) regular member assigned to the Ladysmith RCMP Municipal Police Unit starting in 2027 and request an amendment to the Municipal Police Unit Agreement with the Minister of Public Safety and Solicitor General reflecting a total of 9 municipally-funded members in the 2027/28 RCMP fiscal year; and

2. Authorize and include in the 2026-2030 Financial Plan an increase of one (1) regular member assigned to the Ladysmith RCMP Municipal Police Unit starting in 2029 and request an amendment to the Municipal Police Unit Agreement with the Minister of Public Safety and Solicitor General reflecting a total of 10 municipally-funded members in the 2029/30 RCMP fiscal year.
