9. CVRD Update

Mayor Beeston reported that the CVRD tax increase was finalized at just under 4% and that free tipping for yard and garden waste would be discontinued and replaced with a minimum user fee, resulting in an estimated tax decrease of about \$1 per \$100,000 of assessed value. It was further reported that Association of Vancouver Island and Coastal Communities (AVICC) resolution priorities were set to focus on forestry and private managed forest lands.
