

Zoning Bylaw/Official Community Plan Amendment  
Bylaw Nos. 2068 and 2069  
May 20, 2025, 6:00pm

Pursuant to Section 466 of the *Local Government Act*, we advise you that a Public Hearing has been scheduled to consider amendments to Covenant CB215820, which was registered as a condition of approval of "Official Community Plan Bylaw 2003, No. 1488, Amendment Bylaw (No. 65) 2021, No. 2068" and "Town of Ladysmith Zoning Bylaw 2014, No. 1860, Amendment Bylaw (No. 37) 2021, No. 2069". Anyone who considers their interest in property to be affected by the proposal will be given reasonable opportunity to be heard.


#### Subject Property

**1130 Rocky Creek Road:** LOT 1 DISTRICT LOTS 24 AND 38 OYSTER DISTRICT PLAN EPP110197 (PID: 031-792-022)

#### What is the Proposal About?

If approved, the amendments to Covenant CB215820 will:

1. Remove a requirement for the developer to construct a roundabout in the Ludlow Road/Rocky Creek Road Intersection; and
2. Add the following new conditions:
  - a. a prohibition on access from Ludlow Road and right out only access onto Ludlow Road until the roundabout is constructed;
  - b. a requirement to construct a temporary median in Ludlow Road prior to issuance of an Occupancy Permit;
  - c. a requirement for cash in lieu of frontage improvements along Ludlow Road and Rocky Creek Road at time of building permit issuance;
  - d. a requirement to install a temporary gravel pathway along the frontage of the property at time of building permit issuance; and
  - e. a requirement to install certain signage in the Ludlow Road right of way to prevent left hand turns and U turns.
