The meeting was called to order at 5:00 p.m.

1. **PRESENTATION**

J. Winter presented on "Governance and Effective Meetings" and provided guidance to HRAC members throughout the meeting to assist in running an effective meeting.

2. **AGENDA**

It was moved, seconded and carried that the Agenda of June 21, 2018 be approved with the addition of 6(c) Lady Cynthia Rhododendron Update, and 6(d) Membership Term Expiration.

3. **MINUTES**

It was moved, seconded and carried that the Minutes of April 19, 2018 be adopted.

4. **COUNCIL REFERRALS/UPDATES**

Councillor Hutchins applauded recent investment in Ladysmith's downtown, including 431 First Avenue (former Barb's Kitchen) and 422 First Avenue (Traveller's Hotel). Councillor Hutchins also noted the recent adoption of the Waterfront Area Plan, and the upcoming Councillor Candidate information session on Tuesday, June 26th.

5. SIGN/FAÇADE APPLICATIONS

- (a) Sign Permit Reflections Natural Health (512 First Avenue) Members reviewed the proposed signage for the door and existing awning.
- (b) Sign Permit By the Sea (32 High Street) Members reviewed the proposed façade signs.

It was moved, seconded and carried that the Heritage Revitalization Advisory Commission supports the proposed signage for "Reflectiens Natural Health" at 512 First Avenue, and "By the Sea" at 32 High Street.

7. NEW BUSINESS/UPDATES

a) Metal Collage Sub-Committee Update

The Metal Collage Sub-Committee reported that approximately 10 photographic images could be added to the west side of the metal collage at a cost of approximately \$30 per image. The sub-committee suggested that photos depict post-1930's Ladysmith on the blank (west) side of the collage.

It was moved, seconded and carried that the Heritage Revitalization Advisory Commission recommends to Council that the Metal Collage Update be added to the 2019 budget to purchase and install additional photos and provide legends for both the east and west sides of the collage.

b) Heritage BC Conference report

R. Johnson provided a summary of the Heritage BC conference he attended in May 2018. He showed HRAC members a short video that he presented at the conference, summarizing recent heritage projects throughout Ladysmith.

Councillor Hutchins will invite members of HRAC to attend a Council Meeting and will present Council with the heritage conference video segment, along with a Ladysmith "Lives & Legends" video.

c) Lady Cynthia Rhododendron Update

It was moved, seconded and carried that the following motion be rescinded from the April 19, 2018 Heritage Revitalization Advisory Commission minutes: It was moved, seconded and carried the Heritage Revitalization Advisory Commission recommends to Council that support or assistance be provided to the property owner of 226 Kitchener Street to maintain the condition of the Lady Cynthia Rhododendron.

d) Membership Term Expiration

Members inquired about the upcoming expiration date for some members. J. Winter outlined the upcoming Commission Review and asked that members with expiring terms consider an extension until January 2019.

It was moved, seconded and carried that Heritage Revitalization Advisory Commission members support the extension of the membership terms until January 1, 2019 due to the Commission Review process.
