GENERAL ACCOUNTABILITY

This is a skilled supervisory position reporting to the Captain. The POC Lieutenant is responsible for coordinating firefighting and other emergency service activities. The Lieutenant supervises the maintenance of apparatus, equipment and facilities. The POC Lieutenant assists the Deputy Fire Chief of Training and Operations in preparation and delivery of firefighting training. During emergency operations assignments are within the Incident Command System. The POC Lieutenant is evaluated in terms of their leadership abilities, and performance of their primary duties and accountabilities.

- Assists and participates in scheduled training sessions
- Participates in weekend standby and duty officer responsibilities as required

- Maintains records, prepares reports and memos
- Performs related duties as assigned
