Signed Tenders in sealed envelopes that are clearly marked "Tender for Town of Ladysmith, Roberts Street Watermain Replacement" will be received at the Town Hall, 410 Esplanade, Ladysmith, B.C., up to **2:00:00 pm local time, Thursday, May 16th, 2024**, after which time they will be opened by Town staff. The Tenders will not be opened in public. Tenderers may request unofficial results following the opening.

The work includes the supply of all materials, labour and equipment required to install approximately 140 metres of 150 mm dia. and 165 metres of 200 mm dia. PVC watermain piping including water services, fittings, valves, tie-ins, and a fire hydrant. The work also includes the installation of approximately 32 metres of 200 mm dia. and 103 metres of 300 mm dia. storm sewer piping including catch basins and manholes.

Tender documents will be available from Koers & Associates Engineering Ltd., after **11:00 am local time, on Monday April 22nd, 2024**.
