

Subject Property

379 Davis Rd. (Lot A, District Lot 43, Oyster District, Plan VIP69091).

What is the Proposal About?

If approved Bylaw No. 1994 will amend the Official Community Plan by designating the subject property at 379 Davis Rd. as 'Single Family Residential' and by removing 'Development Permit Area 3 – Commercial' from the subject property. Bylaw No. 1995 proposes to zone the subject property to 'Single Dwelling Residential (R-1)'; and proposes to remove the 379 Davis Rd. site specific regulation from the C-5 Zone.
