	The group would like to form a committee to explore improvements to Ladysmith's skatepark. Many other regional district have recognized the need for and invested in their own skateparks. The park should be an inclusive experience to create a safe and enjoyable modern skatepark for all ages and abilities. The group feels that there are some safety concerns that need to be addressed such asthe sharp change of gradient, wheels can get stuck in the cracks, the box is too close to the quarter pipes in a high speed area. The design is a very open layout with a lack of features to maintain momentum throughout the skatepark.

The Committee provided the following feedback to the delegation:

- 1. Work on the concept plan i.e. design, elements, features with budget and some possibilities to create a preliminary vision to help get to the next step.
- 2. Make the public aware of the project and begin fundraising through service clubs and community groups.
- 3. Distinguish between the maintenance problems that are safety related versus the design issues ie. list of maintenance issues with photo of each in order to request increased funding from the Town (short term plan).

#### 2. Park Implementation Plan: In-Person Engagement

The Committee discussed engaging and interactive activities such as:

- 1. Stops with map and information similar to self-guided tours focusing on:
  - Entry point
  - Playground
  - Storybook walk •
  - Trails through the forest •
  - Creek
  - **Open space** •

# **RECOMMENDATION:**

# **EXECUTIVE SUMMARY:**

The purpose of the Community Banner Program is beautification and community identity promotion. Community banners add vibrancy and community spirit throughout Ladysmith and will represent Ladysmith's small town charm, coastal community life and diverse cultural heritage. The Public Art Task Group (PATG) recommends themes for the program and makes its recommendations to Council through the PRCAC as per the group's Terms of Reference.

The Community Banner Program showcases the downtown core, and the Transfer Beach Boulevard.

# Purpose of PATG and Coordination of the Community Banner Program

In November 2020, the PATG was formed. The purpose of the PATG is to assist the Town with:

• Providing advice and recommendations to Council on specific Public Art projects, including selection processes, acceptance of grants, gifts, donations, bequests and deaccession.

The PATG has two functions:

(a) To advise the Town on public art issues and trends relevant to public art initiative in Town.







(b) To advise on specific issues, such as donations, deaccession, and commissions of work.

The PATG will review matters as outlined within the purpose of the PATG, and make recommendations to Council through the Parks, Recreation & Culture Advisory Committee.

In consulation with the PATG, Staff will manage the Community Public Art Banner Program. The PATG will recommend the theme for the Banner Program to Council through PRCAC and the PATG will strike a selection panel to choose and recommend the Public Art Banners to Council through the PRCAC.

# THEME RECOMMENDATION

The PATG recommends a theme that showcases art that connects people, promotes peace, spreads positivity, creates opportunities to be together, focuses on relationships, and celebrates diversity. Ladysmith and Stz'uminus' natural environment inspires creativity, and community events and gatherings create the connections we all need to feel a sense of belonging.

The Public Art Task Group recommends the 2023 banner theme of "**Connecting Ladysmith through the Arts**" for consideration by the PRCAC.

# INTRODUCTION/BACKGROUND:

There are approximately 160 banners throughout Ladysmith. Current locations of the banners are in the downtown core and Transfer Beach Boulevard.

The Community Public Art Banner Program for 2023 includes new designs in the downtown core along First Avenue from Symonds Street to Robert Street.

The annual Public Art Banner themes will be recommended, and presented to Council for consideration. Once the theme is confirmed, the Call for Artists process will commence.

Each year, banners are displayed from May to October. The Community Banner Program has an annual budget allocation.

# FINANCIAL IMPLICATIONS;

The existing annual operational funding for the banners will be used for the Community Banner Program. It is not anticipated that additional funding would be required. Existing funding would continue to cover artists fee, as well as design and production costs.


