Recreation Needs Assessment

• The regional recreation initiative is now in its fifth year, having begun with a slow rollout.

- Requisitions are based on usage metrics, such as the percentage of paid program participation from the Frank Jamseson Community Centre and other regional facilities.
- Public consultations for the recreation needs assessment are currently underway.
- Committee members raised inquiries about usage balance and concerns around equitable local access, particularly from the Nanaimo area.

Lot 108 Update

- The tender for outdoor fitness equipment (Phase 1) has been finalized and will be issued once a contractor is selected.
- A tennis court is planned as part of the sports field development in future phases.

OLD BUSINESS

Rutti Park Plan - Open House survey update

- The committee agreed to proceed with Option 3 for the park design.
- Full feedback from the open house and survey were shared with the committee.
- A final implementation plan for Rutti Park is expected before the end of year.

Emergency Access Lane though Brown Drive Update

- Development Services staff have engaged with BC Hydro property owners to examine slope/grade constraints and alternative access solutions in coordination with the Fire Department.
