The Engagement Process

The Town of Ladysmith and Stz'uminus First Nation have partnered in the development of a Waterfront Area Plan. This process has involved engagement of community stakeholders and land owners to confirm and/or develop the vision and community planning goals, objectives, and policies for the Waterfront Area. As of August 11, 2017, an estimated 1500+ distinct participant interactions took place.

Phase 3 engagement involved presentation of a draft Waterfront Concept to stakeholders and the broader community for comment and review. Activities included:

- Joint Commission and Charrette Team
- Property Owners and Tenants Workshop
- Public Drop-In Open House
- Online Survey

This report summarizes participant input, which will be used in creating a final Waterfront Area Plan.



Joint Commission and Charrette Team Workshop

On July 18th, the Charrette Team that had gathered during the early stages of the project reconvened to review the draft Waterfront Area Plan, and they were joined by members of Town advisory commissions. The group met at Aggie Hall during the evening. The 38 participants included:

- Eleven citizens at-large;
- Nine representatives from the following Town commissions and/ or organizations: Ladysmith Maritime Society, Ladysmith Arts Council, Ladysmith and District Historical Society, Advisory Design Panel, Advisory Planning Commission, Heritage Revitalization Advisory Commission, Ladysmith Chamber of Commerce, Ladysmith Downtown Business Association, and Parks, Recreation and Culture Advisory Committee;
- Members of Ladysmith and Stz'uminus Councils;
- Members of the Advisory Planning Commission, Advisory Design Panel, Heritage Revitalization Advisory Commission, and Parks Recreation and Culture Advisory Committee.

The following pages summarize the activities and outcomes of the charrette event.



Joint Commission and Design Charrette Team Feedback

For the workshop, the charrette team broke up into five groups to review draft annotated plans, sections and vignettes. Conversations focused on what was working well; what was missing; and what needed to be re-considered. Some groups also recorded their input directly over the concepts. A full transcript of the comments is available in the appendix.

The section below summarizes the responses received.

Key themes for what is working well:

- A welcoming and inclusive plan
- The addition of the Cultural Centre
- Additional connectivity and walkability including the waterfront walkway

Key themes for what is missing:

- Further exploration of cross harbour connections between the Town of Ladysmith and the Stz'uminus First Nation
- RV parking potential for overnight in certain areas

Key themes to re-consider

- RV access
- How the phasing and economics for the project will work







Property Owner and Tenant Workshop

On July 19th, property owners and tenants gathered to review the draft Concept Plan in the Welcome Centre meeting room at the LMS Community Marina. Approximately 15 people were in attendance, of which several attended the workshop the previous day.

The former worked with a graphic facilitator to work through the plan in a more indepth manner. The latter worked through what was working, what was missing and what needed to be re-considered. 

Feedback from the "fresh eyes" table:

Within this group there was a rich exploration of functionality of the working waterfront and opportunities for expansion of marine services including:

- Fuel dock a good location is near the existing commercial wharf. There is an existing fuel spill response kit there and trained personnel
- The need for a crane
- · The need for proper truck access
- The potential to bring back the herring business to the island
- Positive reaction to Slack Point Park and the Live-Work area
- Design considerations for the expanded marina to accommodate access for future repairs and maintenance and boat ramp parking lot to accommodate drivers with boat trailers



Drop-In Public Open House

Most of these questions are too pie in sky: eq. honouring the earth and the water?

Significant concept and jurisdictional conflict between honoring earth and water and the commercial waterfront. Little of these are within the ToL jurisdiction or boundaries. A plan to address these goals with affected partners is needed. And, why has the ToL and SFN not engaged directly with the LMS Board. LMS is one of the centrepieces in this plan, currently updating its own strategic plan.

All of this is wonderful all we need to do now is find the money and resources to make it so. Really like what you are doing.


Very important to develop some Design Guidelines for the different component in this development, representing the Town and the Indigenous presence.

I'd love this to be a walkable, safe, clean destination for surrounding communities and visitors alike.



Do you have any suggested changes? (representative comments):

- split walking trails to add bike paths (or add a separate bike path) and have fitness trails and stations sprinkled through Slack Point park. Add dog walking trails (or allow dogs on all walking trails) and have beach area where dogs are allowed so families with dogs can play together.
- This would have been easier if delivered in stages. It's so outrageously unaffordable as it is, one has trouble responding.
- Residential is a crucial component of this. But where's the grocery store? Pharmacy? Starbucks? Etc.
- The Waterfront Inn proposed is a great idea. It would be great to be able to go to a nice place with a great view to eat in Ladysmith. Also, I think that the Tech industry is something Ladysmith should be trying to attract, particularly at this time (given the current political climate).
- Plan is excellent! I'm just wondering what the "boutique" hotel is going to be. I would prefer something
 like a Holiday Inn or Coast Hotel (i.e. high quality but reasonably priced) to an overpriced, exclusive
 "boutique" hotel (unless I'm misunderstanding what you intend).
- Why not have serviced camping (not live-in) instead of Slack Point Park. Bringing in more revenue and having extra pedestrian traffic on boardwalk and downtown.
- Please make sure that there is housing that will be affordable for our own community. Available and affordable residential homes are disappearing as people discover our town. There also needs to be more homes that meet the needs of seniors who want to live in their own homes.
- Who wouldn't agree with all of this if it's free? How will you pay for it and clean up the Harbour without quadrupling taxes?
- More tourism type activity and more recreational type activities. More markets, or restaurant or other type facilities. Take the best of places like Coombs, Parksville, Nanaimo, even Victoria. Ladysmith has the potential and this is the best opportunity to do it.
- Include commercial areas for leasing opportunities. You are sitting on a gold mine here. Allow space for unique restaurants/cafes, unique shops, maybe a waterfront brewpub? I know I would be visiting places like these quite often. You can literally go anywhere in BC if you want to see native culture. Make this our own.
- I am strongly against any residences built ANYWHERE in the park. Also this survey time needs to be extended by another month to the end of August. This is not enough time for the citizens to complete this survey in my opinion. Also there is no summer swimming pool proposed. No tennis courts or squash courts.

Do you have any additional comments? (representative comments):

- It would be very cool to have a loop with a mini steam train or a solar powered carriage system that could pick up and drop off people in waterfront development and downtown. It would have stops at cultural and heritage sites and viewpoints destination "ride" for tourists and practical people mover for connecting downtown and waterfront.
- With increased traffic, it will be even more imperative that a traffic loop be completed at Transfer Beach so all cars are forced to do u-turns.
- There should be a better plan for a bike path. Having the bikes share the walking path would never work as there are stairs. You will just end up with bikes on the boardwalk where they may be more of a problem I'm looking for it to start tomorrow....!!!!! It's a very well thought out and constructive plan! Thank You
- I am excited to see these plans reach reality. I very much support keeping access to our beautiful waterfront open to the public and support for public walking trails would be my highest priority. On that point, are there plans to extend walking trails along the waterfront of Oyster Cove and connect to the estuary park? I think we should follow the examples of Nanaimo, Victoria and Vancouver in developing lengthly waterfront walking paths.
- I think personal live-in housing of any type in this area creates a nest for elitism and future problems. The waterfront area should remain 100% available to the public. Housing developments seem to be doing well on the back side of the Town. People with ownership rights tend to be wealthy and territorial with a big stack in their own advancement. Public land should be equal- opportunity land an remain so for the long run. (My bias based on observation....ie. The Beach front at Parksville)
- Machine Shop will make a great Arts Centre for community gathering in music, dance, visual arts, indigenous arts etc so exciting!
- Love it! Let's go!
- I have questions. How will the development be financed? What percentage of the cost would be paid out of local taxes? What is the time-frame for implementation of the Plan? Which external businesses are interested in participating. What are their mandates and requirements? For example, what is the interest of Oak Bay Marina in acquiring crown land at Ladysmith Harbour (application # 1412701)? Is this interest connected to the Waterfront Plan, or is it a separate venture entirely? What is the role of the Ladysmith Maritime Society in the conception and implementation of the Waterfront Plan? Where can Ladysmith residents see a model of the Plan that makes sense, rather than having to decipher the inadequate maps presented online?

PROJECT BACKGROUND

PARTNERSHIP HISTORYStz'uminus First Nation and Town of Ladysmith

In 2007 and again in 2012, the Town and Stz'uminus First Nation signed a Community Accord to work together to build a better relationship and develop partnerships for the mutual benefit of both communities.

The Naut'sa Mawt (Working Together) Community Accord has been further strengthened by the signing of a Memorandum of Understanding identifying 16 potential joint initiatives, including Ladysmith harbour clean-up and an expansion of marina services.










ENVIRONMENT AND ECOLOGY

From 2009 to 2012, archaeological, environmental, and geotechnical reports were prepared for the undeveloped Town and Provincial lands. The estimated volumes of poor quality soil and sediments, and the associated costs to remove and dispose of all contamination, are very high. The charrette process explored different strategies for approaching this important challenge, which will ultimately shape development feasibility and vision implementation.















WHAT WE HEARD

Design Charrette

In March, a group of citizens took part in a "charrette". A charrette is an intensive and collaborative design exercise meant to create solutions to a design problem. For this exercise, the role of the charrette was to bring together community members with diverse insights and perspectives, and to collaboratively explore land use and design concepts for the waterfront study area.


The charrette team was provided with input received to date from the Ladysmith and Stz'uminus communities on priorities and ideas for the future of the waterfront. Using this community input as a guide, the charrette team worked to develop ideas for the future of the waterfront. 7,11,12 above are a bit unclear as goals.

As I viewed the large open green space on Slack Point at today's presentation, it looked quite empty - almost like you have a phase II up your sleeve. Hopefully it will be filled in with lots of 'interesting stuff' and not left simply as grass. I realize there are probably seismic and toxic issues out there but hope better/different use can be found for that space.

Will there be a pump out station at the marina to reduce pollution in the harbour? Were float homes considered? They would give a year round "people presence" in the harbour and provide revenue for the town. Construction costs would also be less than land based housing.

Most of these questions are too pie in sky: eq. honouring the earth and the water?

I didn't answer most of the questions. They are incredibly buzzwordy and opaque. Example: "authenticity of the waterfront". That means literally nothing on its own. Is reverting to picking shellfish "authentic"? Are log booms "authentic"?

is there mention of cleaning up the derelict boats, which would and should be first step.

I think the statement about walking is vague. You cannot make the act of walking delightful only enhance the physical environment to encourage people to do so. Consider: "create a physical environment that encourages and engages walkers"

No. 8 strength used too many times.

Get rid of the mills

#11 feels like just buzzwords and doesn't say anything useful to me; to some extent the same for #4 - "authenticity and integrity"? - just ask the Stz'uminus people; #2 emphasizes 'on the water' yet the Vision statement says "on the land and in the water" - it feels uncomfortably as though the partnership applies more to the water than to the land.

#2 - the Vision statement says "...on the land and in the water" - the #2 goal words feel like Stz'uminus is being restricted more to the water, creating confusion about the real extent of the partnership; #4 - I am not sure that 'authenticity and integrity' of the working waterfront are words that the Stz'uminus would choose to describe what has gone on - perhaps 'continuity' or 'present character' would fit better?; #11 - these feel like buzzwords to me - I have no idea what this says. #8 - On July 18 our group (with Norm Hotson) discussed use of the term "Cultural Hub" and concluded that different words were needed to distinguish the Stz'uminus/traditional Cultural Centre from the Inustrial Heritage/Arts focus of the more northern site.

Possible other "satelite" locations for First Nation art, activities, inter-active projects with Stz'uminus

Significant concept and jurisdictional conflict between honoring earth and water and the commercial waterfront. Little of these are within the ToL jurisdiction or boundaries. A plan to to address these goals with affected partners is needed. And, why has the ToL and SFN not engaged directly with the LMS Board. LMS is one of the centrepieces in this plan, currently updating its own strategic plan.

All of this is wonderful all we need to do now is find the money and resources to make it so. Really like what you are doing.

Must work together always!

very important to develope some Design Guidelines for the different component in this developement, representing the Town and the Indigenous presence.

How can you 'honor' both 3 and 4 when 4 essentially destroyed 3?

I would be very hesitant in maintaining traditional uses of the waterfront area; we have much better knowledge about the world and environment than we did in the past and we should utilize that knowledge instead of blindly following past actions. I feel there is an opportunity to also incorporate athletic facilities that could provide benefits to the community.

There are too many generalities in this section.

Show us the money for soil remediation. Show us the money from investors. Show us the money from other levels of government. It takes a lot of capital to develop a waterfront. This is a pipe dream

I'd love this to be a walkable, safe, clean destination for surrounding communities and visitors alike.

Please don't take up the green space by building too many buildings and townhouses.

8. Cultural and Heritage Hub - Add ... and restoring and maintaining our heritage buildings because they are the only intact remnants of the waterfront's industrial past and share the story of an important era in LADYSMITH'S history.

extend the waterfront walkway to connect with the Holland Creek Trail

I hope the specifics of #12 will be relayed to the public for further input/surveys.

I would like to see the words 'Industrial Heritage' used along with 'Cultural' in the Goal Statements and other descriptions of importance in the proposed development.

While I like the idea of 12. Residential Development, I think there should be less than what has been included. The Waterfront Inn proposed is a great idea. It would be great to be able to go to a nice place with a great view to eat in Ladysmith. Also, I think that the Tech industry is something Ladysmith should be trying to attract, particularly at this time (given the current political climate).

#2 - possibility for seasonal sale of fresh seafood?; #9 - see previous discussion identifying the need for another name here, such as Industrial Heritage/Arts to distinguish it from the Stz'uminus/traditional Cultural Centre; #12 - Implicit in the plan is the notion that revenue from residential development will fund other waterfront amenities - if this is an important premise then it would be helpful to see some ballpark financial figures. BUT the absence of discussion about the marina is glaring, yet this is perhaps the most significant area for true partnership between the two communities and is the centrepiece for the entire waterfront! It cannot be simply ignored on this illustration. Rather it requires a category of its own. Also the pub generates much interest and requires mention. Several factors would suggest that a site for the pub nearer Transfer Beach might be better - excellent view over Stuart Channel, better access (closer parking/no stairs) for mobility-impaired, and reduction oif parking congestion near the marina access point. A small cafe could continue in the marina for lighter fare.

I like the infill proposed to improve access to the waterfront, an excellent solution. As the marina is proposed to be significantly increased in size, will a devise for off-loading of waste, specifically sewage, be provided? This could lessen the pollution in the harbour. Also, were spaces for float homes considered? This could give a year round "people presence" in the harbour and provide year round revenue for the town at less expense the land based development.

Who wouldn't agree with all of this if it's free? How will you pay for it and clean up the Harbour without quadrupling taxes?

just that none of the buildings be too tall.

The scope of the goal statements is both overambitious and piecemeal. Given the current and past sorry state of the waterfront area, Ladysmith Council does not have a good track record in areas of sustained innovation and change. In 10 years things have gone downhill. Compare Ladysmith with, say, Cowichan Bay, a vibrant, interesting place that people want to visit AND you can get a meal there on a Monday. Stz'minus Cultural Centre (4) on the water looks like a separate enterprise. The cultural Hub (9) description looks vague. What would happen there. Why could 4 and 9 not be integrated? That would make more sense. Why

is there no evidence of how the development would be phased in. That seems to me to be critical. Furthermore, The 'boutique hotel' (11) has not been thought through. Boaters would mostly stay on their boats. Even if all 13 aspects of the Plan were up and running, there would not be enough to attract overnight hotel guests to Ladysmith. That is why any plan for the waterfront needs to go hand in hand with a correspondingly dynamic plan for revitalization of the town core.

I would like to see more tourist and town resident friendly services such as a market, restaurants, coffee or ice cream shops, maybe a fishermans market possibly, waterfront and water friendly outdoor activities...

Maybe even mini golfing, etc.

Is this interest connected to the Waterfront Plan, or is it a separate venture entirely? What is the role of the Ladysmith Maritime Society in the conception and implementation of the Waterfront Plan? Where can Ladysmith residents see a model of the Plan that makes sense, rather than having to decipher the inadequate maps presented online?

Again, take the opportunity to learn from other local cities hotspots and attractions. Ladysmith is so great and has so much potential. Now is the opportunity to capitalize on it. Also on another note, the fact that the waterfront is going to be cleaned up is fantastic and is obviously the highest priority among anything else.


No mention anywhere of future thoughts about LMS which has existed on the waterfront for 32 years to provide affordable moorage for local boaters.
